Tugtar fógra leis seo go bhfuil sé beartaithe ag Comhairle Cathrach Bhaile Átha Cliath, an tÚdarás Pleanála do Chathair Bhaile Átha Cliath, Dréachtphlean Ceantair Áitiúil (LAP) a ullmhú le haghaidh **tailte ag Eastát Tionscail Bhaile Átha Cliath agus a phurláin**, Baile Átha Cliath 7 agus Baile Átha Cliath 11, agus go bhfuil sí anois ag glacadh páirte i gcomhairliúchán réamhdhréachta de bhua Alt 20(1) d'Acht um Phleanáil agus Forbairt, 2000 (arna leasú) ón **Aoine, an 28 Aibreán go dtí an Aoine an 26 Bealtaine 2023**.

Reáchtálfaidh Comhairle Cathrach Bhaile Átha Cliath roinnt seisiún faisnéise buail isteach i rith thréimhse a taispeána poiblí chun an próiseas a bhaineann leis an LAP a chur i dtoll a chéile a phlé agus a mhíniú, atá ainmnithe go sealadach mar LAP Bhaile Bogáin, agus cabhróidh foireann na Comhairle leo siúd a bhfuil ceisteanna acu maidir le conas aighneacht a dhéanamh. PLANNING AND DEVELOPMENT ACT 2000 (AS AMENDED) SECTION 20(1)

Notice is hereby given that Dublin City Council, being the Planning Authority for Dublin City, intends to prepare a Draft Local Area Plan (LAP) for **lands at Dublin Industrial Estate and environs**, Dublin 7 and Dublin 11, and is now engaging in pre-draft consultation pursuant to Section 20(1) of the Planning and Development Act 2000 (as amended) from **Friday 28th of April to Friday 26th of May 2023**.

Dublin City Council will hold a number of drop in information sessions in the locality over the period of public display to discuss and explain the process for making the LAP, provisionally named as the Baile Bogáin LAP, and will assist with any queries in relation to making a submission. Information on dates and venues for these drop in sessions will be made available on the Dublin City Council website. Please check www.dublincity.ie for further updates during the display period.

A 'Pre-Draft Issues Paper' has been prepared to give a broad overview of the main development issues facing the area and to stimulate public debate on what broad planning and development matters should be considered in the new LAP. All valid submissions and observations received with respect to the Proposed Draft LAP made to the Planning Authority up to and including **Friday 26th May 2023** will be taken into consideration during the preparation of the Draft Baile Bogáin LAP. Please note late submissions/observations will not be considered.

This pre-draft consultation phase will inform the preparation of the Draft Baile Bogáin LAP, which will be subject to further consultation at a later stage and will be accompanied by an Environmental Report prepared as part of a Strategic Environmental Assessment under the Planning and Development (Strategic Environmental Assessment) Regulations, 2004 (as amended). The Draft LAP will also be subject to Appropriate Assessment requirements under the Habitats Directive (92/43/EEC).
